

May 2012

The meeting was called to order at 6:09 p.m.

Roll call/intro Roll call/intro: there was a quorum with the following board members present: Charleene Naughton, Kristin Yancey, Linda Siegel, Jean Zabriskie, Valerie M Logsdon and Cheryl Hansen. Approval of previous minutes, as amended (Jean Zabriskie moved, Charleene Naughton 2nd) motion passed.

Finance: Treasurer's Report was provided by Jean Zabriskie . We have a balance of \$6,188.48. Fuzzy Wuzzy earned a net of \$1,288.15 at this time. Submission and approval of expenses. Linda Siegel provided a receipt for paper supplies: \$69.41. Cheryl Hansen provided a receipt for food in the amount of \$14.39. Valerie M Logsdon moved that the proposed expenses be approved; Kristin Yancey 2nd; the motion passed.

Old Business: Fuzzy Wuzzy- there was a great turn-out (85 riders) with many first-time riders; especially as this was a rain date. Newsletter report – we need to add the board members' email, so that it is the easiest way to contact officers. We should receive a new email address from Mother Lode to avoid the monthly \$21.95 expense. It was decided that email will be info@mlaha.org. By-Laws report - we need a better sense of terms and attendance at meetings. Right now, only the delegates are required to attend. Trail Trials - As Colleen Jones resigned, we will need another in charge. September 9th was provided as a tentative date. Valerie Logsdon needs to look at whether there are any conflicts. Park watchreport.org showed no conflict. Website: we need updated information, i.e. trail trials, FW, All members can send a photo (no larger than one-half megabyte) of a horse for sale, for general info to Linda Siegel. Horse Expo: there is an author's table. The schedule should coming out this Friday. Linda will set up the booth.

New Business: Christmas Party: We need to start to plan for this event, it was a lot of fun. Generally, it is always the first Tuesday in December: December 4th. Douglas Ranch wanted to sponsor dessert. Board Terms: We will need to look at who will be turned out. Cheryl needs to turn into a delegate. Appointment of board member for remainder of year; Marilyn Hunter was asked to serve. The President appointed and the board confirmed this appointment. Create a board meeting/Ranch meeting. Discussion regarding where a possible venue for members to visit. Ice cream social with sundaes.
