- IV. Finance

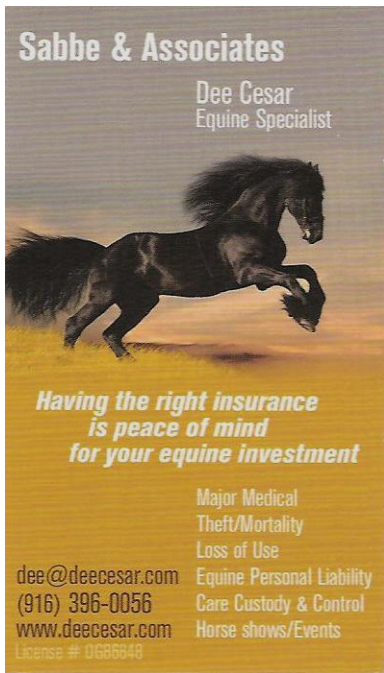
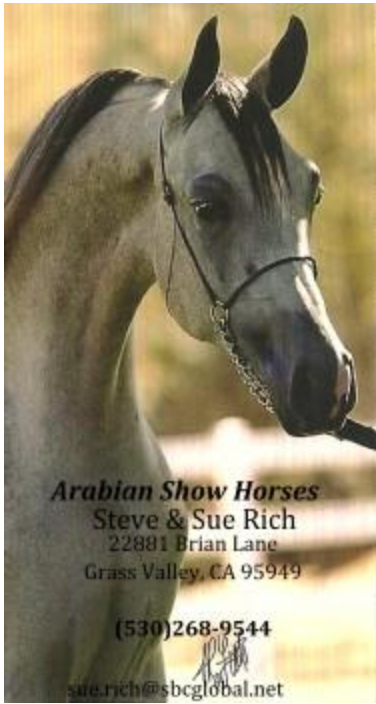
